(Anti-Graffiti Coating)

**All Acryli-Master coating jobs must be reviewed prior to and upon completion of application with TSW, Inc.**

This Stuff Works, Inc (hereafter referred to as TSW), warrants TSW8 Acryli-Master to be an effective surface shield against all common coating forms of graffiti vandalism for a period of five years from the date of initial application when applied per manufacturer's application instructions and properly maintained. TSW's five year limited warranty is for the replacement of material only and there are no other warranties expressed or implied.

If, upon inspection, TSW determines that this claim is covered under warranty, TSW shall at its own expense, supply sufficient TSW Acryli-Master material to restore all non-conforming areas where necessary as the result of any defect in this product. TSW shall have no obligation to contribute or participate in the labor costs necessary for installation or to affect repairs. The foregoing shall be the only remedy of the Owner or Licensed Applicator under this Limited Warranty.

The duration of the Limited Warranty shall not be extended by the supplying of any replacement material but the remaining Limited Warranty period shall be in effect and is applicable to the restored areas under the conditions of the Limited Warranty. Any claim under this Limited Warranty shall be presented in writing to TSW at the address above during the Limited Warranty period and within Forty-Five days after any covered condition has occurred by sending written notice to TSW. Failure to provide written notice within the specified time period shall discharge TSW from any and all obligations under this warranty.
